



Dear Parents,

Following the elections, which took place from 17 to 20 October 2023, we would like to say a few words about the Board of Directors (BOD) and give you more details about the parents who constitute it as well as the role that each will play over the next academic year.

The Lycée Jules Verne is an approved school of the AEFE system, which is registered in South Africa as a 'Non Profit Company'. As such and according to its statutes, it must have 12 Directors, all parents of children enrolled in the Johannesburg and Pretoria campuses. The BOD has a vital and very complementary role to the school teams (AEFE or local). It must ensure at all times that appropriate means are made available to the establishment so that the pupils receive a quality education and that the health and safety conditions are optimal.
